NOTICE TO IMPORTERS NO. 2 OF 2019

**SUBJECT: THE COMMON EXTERNAL TARIFF
(SUSPENSION AND VARIATION OF DUTY) (NO. 3) ORDER, 2018**

The attention of all Importers is drawn to a suspension and variation of duty of the Common External Tariff (CET) in respect of **Laundry Detergent Powder under Tariff Headings 3402.20.30 and 3402.90.20.**

The suspension of duty on **Laundry Detergent Powder under Tariff Headings 3402.20.30 and 3402.90.20** has been published as the Common External Tariff (Suspension) (No. 3) Order, 2018 vide **Legal Notice No. 199 of 2018**, and the varied rate of duty published as the Common External Tariff (Variation of Duty) (No. 3) Order, 2018, vide **Legal Notice No. 200 of 2018**.

Pursuant to these Legal Notices **Laundry Detergent Powder under Tariff Headings 3402.20.30 and 3402.90.20** **entered** during the period **1st January 2019 to 31st December 2019**, shall have an **increased rate of duty from 20% to 35%.**

Copies of the aforesaid Legal Notices Nos. 199 and 200 are attached for ease of reference.

Importers are to be guided accordingly.

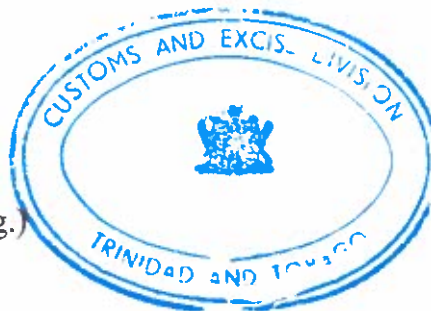
