NOTICE TO IMPORTERS NO. 6 OF 2019

**SUBJECT: THE COMMON EXTERNAL TARIFF
(SUSPENSION AND VARIATION OF DUTY) ORDER, 2019**

The attention of all Importers is drawn to a suspension and variation of duty of the Common External Tariff (CET) in respect of **Soya-bean Oil under Tariff Heading 1507.90.00.**

The suspension of duty on **Soya-bean Oil under Tariff Heading 1507.90.00** has been published as the Common External Tariff (Suspension) Order, 2019 vide **Legal Notice No. 16 of 2019**, and the varied rate of duty published as the Common External Tariff (Variation of Duty) Order, 2019 vide **Legal Notice No. 17 of 2019**.

Pursuant to these Legal Notices **Soya-bean Oil under Tariff Heading 1507.90.00** **entered** during the period **17th January 2019 to 31st December 2019**, shall be admitted **free of Customs Duty**.

Copies of the aforesaid Legal Notices Nos. 16 and 17 of 2019 are attached for ease of reference.

Importers are to be guided accordingly.

1. This Order may be cited as the Common External Tariff Citation (Suspension) Order, 2019.
2. In this Order, where "Ex" is used in relation to an item number under a heading listed in the First Column of the First Schedule to the Customs Act, that item number shall refer only to the corresponding goods described in the Second Column.

3. The rates of duty set out in the First Schedule to the Customs Act, in relation to the goods carrying the headings and descriptions listed below in the First and Second Columns respectively, are suspended for the period specified in the Third Column.
