NOTICE TO IMPORTERS NO. 5 OF 2022

SUBJECT: THE COMMON EXTERNAL TARIFF (SUSPENSION AND VARIATION OF DUTY) (NO. 2) ORDERS, 2022

The attention of all importers is drawn to:

- 1) The Common External Tariff (**Suspension**) (**No. 2**) **Order, 2022** made by the Minister under Section 8A(1) of the Customs Act, Chap. 78:01 and published as **Legal Notice No. 63 of 2022**; and
- 2) The Common External Tariff (**Variation of Duty**) (**No. 2**) **Order, 2022**, made by the President under Section 8A(2) of the Customs Act, Chap. 78:01 and published as **Legal Notice No. 64 of 2022**.

The respective Orders **suspend** and **vary** the rates of duty on the items enumerated therein. The effect is that these goods shall attract the varied rates of duty set out in **Legal Notice No. 64 of 2022** when entered from the date of publication until **30th April, 2022**.
