NOTICE TO IMPORTERS NO. 03 OF 2025

SUBJECT: THE COMMON EXTERNAL TARIFF (SUSPENSION AND VARIATION OF DUTY) (MISCELLANEOUS AMENDMENTS) ORDERS, 2024

The attention of all Importers is drawn to:

- 1) The Common External Tariff (**Suspension**) (**Miscellaneous Amendments**) **Order, 2024** made by the Minister under Section 8A (1) of the Customs Act, Chap. 78:01 and published as **Legal Notice No. 243 of 2024**; and
- 2) The Common External Tariff (**Variation of Duty**) (**Miscellaneous Amendments**) **Order, 2024**, made by the President under Section 8A (2) of the Customs Act, Chap. 78:01 and published as **Legal Notice No. 244 of 2024**.

In the respective Orders:


- (a) where the expression “Ex” is used in relation to an item number under a tariff heading in the First Schedule of the Customs Act and listed in the Second and Third Columns, that item number shall refer to the corresponding goods described in the Fourth Column; and
- (b) reference to the goods described in the Fourth Column, includes the headings and description of goods listed in the corresponding Common External Tariff (Suspension) and (Variation of Duty) Orders listed in the First Column.

An Order listed in the First Column is amended by deleting, wherever they appear in that Order, the tariff heading numbers listed in the Second Column and substituting the tariff heading numbers listed in the Third Column, in relation to the corresponding goods described in the Fourth Column.

These Orders shall take effect from **1st January, 2025**. Copies of Legal Notices Nos. 243 and 244 of 2024 are attached for ease of reference.

Importers are to be guided accordingly.
