The attention of all Importers is drawn to the following:

- 1) The Value Added Tax (**Amendment to Schedule 2**) (**No. 2**) **Order, 2024** made by the Minister under Section 8 (4) of the Value Added Tax Act, Chap. 75:06 and published as **Legal Notice No. 249 of 2024**;
- 2) The Customs (**Remittance of Customs Duty**) (**No. 2**) **Order, 2024** made by the President under Section 9 of the Customs Act, Chap. 78:01 and published as **Legal Notice No. 250 of 2024**; and
- 3) The Miscellaneous Taxes (**Remittance of Online Purchase Tax**) (**No. 2**) **Order, 2024** made by the President under Section 72 of the Miscellaneous Taxes Act, Chap. 77:01 and published as **Legal Notice No. 251 of 2024**.

The respective Orders **amend** and **remit** the rate of value added tax, duty and online purchase tax on the items listed therein when **entered** from **1st January, 2025**.

MADE BY THE MINISTER UNDER SECTION 8 OF THE VALUE ADDED TAX ACT AND SUBJECT TO NEGATIVE RESOLUTION OF PARLIAMENT

THE VALUE ADDED TAX (AMENDMENT TO SCHEDULE 2) (NO. 2) ORDER, 2024

1. This Order may be cited as the Value Added Tax (Amendment to Citation Schedule 2) (No. 2) Order, 2024.
